1. General Information

Products based on [North Carolina Qualified Products List](#), QPL #7105-3.

This contract is mandatory for all state agencies, departments, institutions, universities, community colleges and public school units unless exempted by statute.

Further, it shall be a Convenience Contract, accessible, but not mandatory, for the use of non-State Agencies. Such entities include: nonprofit corporations operating charitable hospitals, local nonprofit community sheltered workshops or centers that meet standards established by the Division of Vocational Rehabilitation of the Department of Health and Human Services, private nonprofit agencies licensed or approved by the Department of Health and Human Services as child placing agencies, residential child-care facilities, private nonprofit rural, community, and migrant health centers designated by the Office of Rural Health and Resource Development, private higher education institutions, counties, cities, towns, governmental entities, volunteer fire departments, rescue squads, and other subdivisions of the State and public agencies thereof. Any non-state agencies that choose to participate in this contract must abide by the terms and conditions that are set forth in this contract.

Computer Workstation Furniture covered by this term contract is intended for use in an office type environment. The intent is not to include all varieties of Computer Workstation Furniture, only those commonly used by State Agencies, departments, institutions, universities, community colleges and public school units unless exempted by statute.

Service Proposal: Service shall consist of calling on State Agencies to discuss their requirements, consulting with agencies in the selection of Computer Workstation Furniture and making recommendations. This does not include any office layout or engineering drawings that may be required.

2. Scope of Contract

The scope of this contract is limited to cover the normal requirements of Computer Workstation Furniture for all State Agencies, departments, institutions, universities, community colleges, public school units (except those exempted by statute) and non-state agencies, for the period from February 1, 2003 through September 30, 2007.

The scope of this contract is limited to Modular Computer Workstation Furniture most frequently purchased for State Agencies, Institutions and the Public Schools. The contract will include basic computer furniture in the form of modular groupings and computer workstations, plus the accessories that are typically associated with a computer workstation. It is required that the modular components of the workstations be contained within a product series of a single manufacturer.

This bid does not include Office Panel Systems associated with any of these approved series listings. This bid refers only to free standing Modular Workstation Furniture.

3. Taxes

Prices or Discounts shown herein do not include any North Carolina sales or use taxes.

4. Abnormal Quantities

Any agency requirement that exceeds \$50,000.00 must be forwarded to the Division of Purchase and Contract for processing. The Division, at its sole discretion, may process any such requirement in one of the following ways:

1. Purchase may be authorized at the current level of pricing with the current contract vendor(s)
2. Additional discounts from the current level of pricing may be negotiated with the current contract vendor(s)
3. A separate Invitation for Bids may be issued for the requirement

5. Minimum Orders

This contract will be for a minimum order of \$250.00 for any single order. Agencies are authorized to purchase from best available sources on orders less than this minimum order value. This provision shall not be used by an agency to circumvent the intent of the contract. If an agency elects to place an order for less than the minimum order value, then transportation charges will be prepaid and added to the invoice.

6. Placement of Orders

Orders will be placed throughout the contract period on an as-needed basis for the quantity required at the time, and will be issued directly to the respective contractor(s) or their authorized dealers. Contract changes, if any, over the life of the contract are implemented by contract addenda released by the Contract Administrator to the contractor. If the contractor is accepting orders and/or delivering through other parties, for example a manufacturer accepting orders and delivering through a dealer network or dealers receiving orders through a network of other dealers, then it is the responsibility of the contractor to apprise such parties of all such contract addenda.

In the event the delivery is not received within the contract delivery period, the contractor may be held in default in accordance with paragraph 1, DEFAULT AND PERFORMANCE BOND in the North Carolina General Contract Terms and Conditions, and the state may procure the articles or services from other sources and hold the contractor responsible for excess cost occasioned thereby.

8. Transportation Charges

All goods shall be delivered FOB DESTINATION for all orders equal to, or greater, than the **minimum order**, when shipped to a single destination. Orders for less than the **minimum order** will be shipped prepaid, with transportation charges added to the invoice as a separate item. Transportation charges levied by the contractor for orders equal to, or greater than the **minimum order**, when shipped to a single destination, may be cause for removal of the contractor from the contract. In instances where the contractor makes partial shipments of an order to one destination, which is equal to, or greater than, the **minimum order**, all shipments of the order shall be sent FOB DESTINATION with NO additional transportation charges.

Note: All shipments should be inspected for damage immediately upon receipt.
