1. General Information

This contract is intended to cover the state’s normal requirements for Desks (Wood), Credenzas, Conference Tables and Related Items. Users should obtain catalogs from the authorized dealer nearest their location to review the various styles offered before placing orders. When placing orders include a contact person’s name on the Purchase Order if possible to assist the dealer if there should be any questions.

All items listed herein meet the requirements of North Carolina Specification No. 7110-7S, latest revision, and North Carolina Qualified Products List No. 7110-7V, latest revision. Both documents can be viewed by accessing our home page <http://www.ncpandc.gov/splist.asp>, Term Contracts and Engineering Section.

2. Scope of Contract

The scope of this contract is limited to Wood Casegoods and Accessories as provided for in QPL #7110-7T (<http://www.ncpandc.gov/qplist.asp>). This contract is for use by all state agencies, departments, institutions, universities, community colleges (except those exempted by statute), and certain non-state agencies.

**NON-STATE AGENCIES ELIGIBLE TO PARTICIPATE IN THIS CONTRACT**

In accordance with North Carolina General Statutes, certain non-state entities described below, may participate in this contract on a voluntary basis. Any of the non-state entities that choose to participate in this contract must abide by the items and conditions that are set forth in this contract.

Nonprofit corporations operating charitable hospitals, local nonprofit community sheltered workshops or centers that meet standards established by the Division of Vocational Rehabilitation of the Department of Health and Human Services, private nonprofit agencies licensed or approved by the Department of Health and Human Services as child placing agencies, residential child-care facilities, private nonprofit rural, community, and migrant health centers designated by the Office of Rural Health and Resource Development, private higher education institutions, counties, public school units, cities, towns, governmental entities, volunteer fire departments, rescue squads, and other subdivisions of the State and public agencies thereof.

### 3. DURATION OF CONTRACT

This contract is intended to cover the user's normal requirements for Wood Casegoods and Accessories for the period from September 1, 2006 (or the award date, whichever is later) until August 31, 2008. However, to prevent a lapse of coverage during the transition from one contractor to another, it may be necessary at times to have overlapping contracts, but this shall be kept to a minimum and only used when the State determines it is in its best interest. In addition, due to unforeseen delays, contractors may be requested to extend the scheduled termination dates of contracts.

### 4. Taxes

Prices or Discounts shown herein do not include any North Carolina sales or use taxes.

### 5. Abnormal Quantities

Any agency requirement that exceeds \$400,000.00 must be forwarded to the Division of Purchase and Contract for processing. The Division, at its sole discretion, may process any such requirement in one of the following ways:

1. Purchase may be authorized at the current level of pricing with the current contract vendor(s)
2. Additional discounts from the current level of pricing may be negotiated with the current contract vendor(s)
3. A separate Invitation for Bids may be issued for the requirement

### 6. Minimum Orders

There are no minimum order requirements for this contract.

### 7. Placement of Orders

Orders will be placed throughout the contract period on an as-needed basis for the quantity required at the time, and will be issued directly to the respective contractor(s) or their designated suppliers. Contract changes, if any, over the life of the contract are implemented by contract addenda released by the Contract Administrator to the contractor. If the contractor is accepting orders and/or delivering through other parties, for example a manufacturer accepting orders and delivering through a dealer network or dealers receiving orders through a network of other dealers, then it is the responsibility of the contractor to apprise such parties of all such contract addenda.

The contractor(s) will complete delivery within the time frame specified below.

In the event the delivery is not received within the contract delivery period, the contractor may be held in default in accordance with paragraph 1, DEFAULT AND PERFORMANCE BOND in the North Carolina General Contract Terms and Conditions, and the state may procure the articles or services from other sources and hold the contractor responsible for excess cost occasioned thereby.

**9. Transportation Charges**

Furniture items shall be delivered FOB DESTINATION to any North Carolina Destination with all transportation charges and inside delivery and setup included in contract price. Inside delivery and setup is to include delivery to agency location, uncrating, assembling (if applicable) and set in place ready for agency use in desired locations as determined by agency personnel.

**Special Note:** Where a loading dock is not available for the contractor’s (dealer’s) use at the user’s site, and/or where an elevator is not available for use for upstairs delivery at the user’s site, the contractor may assess an additional charge for inside delivery. The additional charge is not to exceed the contractor’s actual expenses incurred. The contractor is to furnish the user with an itemized list of any additional charges for inside delivery. The contractor should be notified by the user if any of the aforementioned delivery conditions exist at the user’s site at the time the order is placed. The user and contractor should agree on any additional delivery charges at that time.

**Note:** If the contractor makes partial shipments of an order equal to or more than this “order value” to one destination, all shipments of the order shall be sent FOB Destination with No additional transportation charges added.

**10. Contractor Services to User:**

Upon request of the user, the contractor, or his authorized representative, shall, as a minimum, travel to the user’s site one time to assist the user in determining what specific furniture from this contract that may best suit the user’s needs. This service shall be provided without any additional charge. Contractors are in no way limited in the services over and above this minimum requirement that they may wish to provide the user free of charge. The user is not obligated to procure furniture from any contractor providing these services. The contractor may assess charges for additional trips to the user’s site, over and above the minimum requirements, for the same project. The additional charge is not to exceed the contractor’s actual expenses incurred. If the contractor intends to assess additional charges, then the contractor should notify the user prior to any additional trip(s). The contractor is to furnish the user with an itemized list of any additional charges.

**Note:** All shipments should be inspected for damage immediately upon receipt.

**14. Warranty**

The contractor guarantees items offered to be free from any and all defects in material, packaging, and workmanship and agrees to replace defective items promptly at no charge to the State, for a period of one (1) year from date of acceptance. Such replacement shall include parts, freight, labor, and round-trip travel to the user's site, which will all be the responsibility of the contractor.

**15. Substitutions**

Substitutions are not permitted without prior approval of the Division of Purchase and Contract. Failure of the contractor to comply with this requirement may result in the removal of the contractor from the contract.

**16. Addition of New Series To Contract**

This contract specifically provides for the addition, throughout the life of the contract, of new series offered by the manufacturer. Such new series must (a) be offered at a discount resulting in pricing acceptable to the state as judged by the same factors used for the originally proposed series, (b) meet the current State standard specification for this furniture, (c) be listed on the Qualified Products List (QPL), and (d) have been in documented full production for a minimum of twelve (12) months.

**17. Addition of New Manufacturer to Contract**

New manufacturer(s) for inclusion on this contract will be considered at one (1) year intervals, or less, at the State's option, from the date of award of contract. The State reserves the right to extend this period due to any unforeseen circumstances that may cause a delay in this process.
