## Furniture-All Types– 420A

The Division of Purchase & Contract recently awarded a new State Term Contract 420A for Furniture. The new contract consolidates and replaces the following State Term Contracts: 420A-Furniture, Metal, Folding Chairs, Tables, Storage Units, 420B-Furniture, Classroom, Metal, 420C-Furniture, Lounge, Seating, and Tables, 420D-Furniture, Library, Wooden, 425A-Furniture, Modular Computer Workstations, 425B-Furniture, Desks (Wood), Credenzas, Conference Tables, 425C-Furniture, Bookcases, 425D-Furniture, Chairs, Office, Upholstered, Wood, 425E-Furniture, Chairs, Ergonomic, making the purchase of furniture more user friendly.

The new contract covers: casegoods, classroom furniture, bookcases, ergonomic chairs, office swivel and side chairs, computer furniture, mobile and folding furniture, upholstered seating, and commercial dining tables.

### Excluded from the Contract are:

Metal Filing Cabinets and Storage Cabinets-425H

Orders less than the \$250.00 minimum order amount will be shipped prepaid and transportation charges may be added to the invoice.

Installation charges, design services and project management are allowed under the contract and the amount of the charge must be negotiated with the vendor prior to placing orders.

This is a mandatory State Term Contract for state agencies, departments, institutions, universities and community colleges - unless exempted by North Carolina General Statute. Non-mandatory entities, including schools and local government, may use this contract if allowed by general statute.
